## Majority Disapprove of Cap and Trade Plan Approval highest among the youngest

In a random sampling of public opinion taken by the Forum Poll™ among 1097 Ontario voters, the majority of voters disapprove of the provincial government's plan for a cap and trade greenhouse gas emission control regime which is expected to add about \$13 a month to the average household energy bill (56%), and just more than a quarter approve (28%). About one sixth don't have an opinion on the issue (16%).

Approval of the initiative is characteristic of the youngest (43%), the less wealthy (\$20K to \$40K - 36%), among Liberals (45%), slightly less so among New Democrats (38%) and among the best educated (post grad - 38%).

Disapproval is common to boomers (55 to 64 - 70%), males (60%) rather than females (53%), mid income groups (\$60K to \$80K - 67%), in eastern Ontario (63%), among PC voters (78%) and among the least educated (62%).

"Any government initiative which involves household spending is unpopular, no matter what the stated benefit is. In this case, however, approval is common to the youngest, as well as the best educated, so there may be hope the idea will grow more popular with time and communication" said Forum Research President, Dr. Lorne Bozinoff.

### Methodology

The Forum Poll™ was conducted by Forum Research with the results based on an interactive voice response telephone survey of 1097 randomly selected Ontario voters. The poll was conducted on August 15<sup>th</sup>, 2016.

Results based on the total sample are considered accurate +/- 3%, 19 times out of 20. Subsample results will be less accurate. Margins of error for subsample (such as age, gender) results are available at <a href="https://www.forumresearch.com/samplestim.asp">www.forumresearch.com/samplestim.asp</a>

Where appropriate, the data has been statistically weighted by age, region, and other variables to ensure that the sample reflects the actual population according to the latest Census data.

This research is not necessarily predictive of future outcomes, but rather, captures opinion at one point in time.
